A. 1995 Republican controlled legislature proposed "new" new federalism that would reduce the scope of the national government and give decision making back to the states

- 1. States gained limited control
- 2. Transfer of programs from national to state control (devolution)
- a. speed limits back to state control
- 3. Federal funding came with less restrictions but states had to pick up a bigger share of social service programs
- B. Several important court cases have also pushed this idea of "new" new Federalism restricting the power of the national government
- 1. United States v. Lopez: restricted the power of the national government to pass a law banning guns around school
- 2. Brady Bill: federal government cannot force state governments to comply with federal government programs
 - 3. United States v. Morrison: limited the commerce clause
 - C. More recent cases have not sided with state's rights
 - 1. Gonzales v. Raich; let the DEA prosecute marijuana cases despite state laws
- 2. Health Care Reform Act; split decision that allowed Congress to tax non-insured but prohibited them from penalizing states for nonparticipation
 - D. National government mandates
 - 1. passes regulations that set standards for state conduct
 - 2. force states to spend money to meet standards

- A. 1869 Texas constitution centralized power in the hands of the governor
- 1. Power to appoint Secretary of State, Attorney General and judges
- 2. framework for an operational strong government
- B. Governor Davis administration abuses of these powers
- 1. Obnoxious Acts
- a. creation of state militia and state police force that was formed to help protect against Indian attacks, end lynching of African Americans and halt lawlessness; White Texans had negative impression due to high costs, attitude toward African American officers and the shady way Davis passed the bill
- b. Davis had the power to fill vacancies at state and local level and to hold off elections to make sure Radical Republicans stayed in office
- C. Abuses of power hurt the power and popularity of the Republican Party and Democrats won the majority in the legislature in 1872
- 1. Dismantled the Radical programs but Davis vetoed some of the proposed legislation and Democrats were successful in overriding the veto
- D. Election discrepancies in 1873 caused bad feelings between Republicans and Democrats
- 1. Davis lost in reelection but Republicans tried to use the constitution to invalidate election
- 2. Democrat Coke and Davis both served as governor until Supreme Court, made of appointed Republicans by Davis, voted in favor of Davis
- 3. Davis had to resign without federal military aid to keep violence at bay

- 5. Language used in Texas Bill of Rights secures Texans individual liberties
