TEST BANK

Below are a series of sample questions for the chapters. They have been written for maximum subtlety, often comparing real-life examples with only slight differences. It is recommended that before using any of these examples, you make sure you understand the rationale for the answers. Otherwise students will challenge you on the answers and you will not be prepared to respond.

Also, it is highly recommended that you make modifications to the answers yourself, sometimes to make the answers more explicit, sometimes simply so that you can re-use parts of the questions for different classes by making different answers. Often, some of the "wrong" answers are not fully incorrect, but only "partially" correct. It is easy enough to add what is missing to a "wrong" answer to make it a "right" one, while removing some aspect which makes the "right" answer a "wrong" one. However you use them, just make sure you can defend your choices and be prepared to give partial credit to other answers if students are able to rationalize their choices based on an understanding of the material.
